# CHAIRMAN OF THE CAPITAL MARKET AND FINANCIAL INSTITUTIONS SUPERVISORY AGENCY,

Considering:

In order to implement Disclosure Principles and provide protection to investors, especially for Issuers and Public Companies that list their securities both in Indonesian Securities Exchanges and foreign Securities Exchanges, it is deemed necessary to stipulate Chairman Decision of Capital Market and Financial Institutions Supervisory Agency concerning Time Frame for Submission of Periodic Financial Statement and Annual Report for Issuers and Public Companies that List Their Securities both in Indonesian Securities Exchanges and Foreign Securities Exchanges;

In view of

  - 3. Government Regulation Number 46 year 1995 concerning Capital Market Formal Investigative Procedures (Statute Book year 1995 Number 87, Supplement to Statute Book Number 3618);
  - 4. Decree of the President of the Republic of Indonesia Number 45/M year 2006;
  - 5. Capital Market Supervisory Agency Rule Number X.K.2 Attachment of Chairman Decision of Capital Market Supervisory Agency Number: Kep-36/PM/2003 concerning Obligation to Submit Periodic Financial Statement;
  - 6. Capital Market Supervisory Agency Rule Number X.K.6

#### HAS DECIDED:

To enact

DECISION OF THE CHAIRMAN OF THE CAPITAL **INSTITUTIONS MARKET** AND FINANCIAL AGENCY **SUPERVISORY CONCERNING** FRAME FOR SUBMISSION OF PERIODIC FINANCIAL STATEMENT AND ANNUAL REPORT FOR ISSUERS AND PUBLIC COMPANIES THAT LIST THEIR SECURITIES BOTH IN INDONESIAN SECURITIES **EXCHANGES** AND **FOREIGN SECURITIES EXCHANGES.** 

#### Article 1

Provision concerning Time Frame for Submission of Periodic Financial Statement and Annual Report for Issuers and Public Companies that List Their Securities both in Indonesian Securities Exchanges and Foreign Securities Exchanges is regulated in Rule Number X.K.7 as stipulated in the attachment of this Decision

#### **Article 2**

With the enactment of this Decision, the provisions that regulate time frame for submission of:

- a. Financial statement as regulated in Rule Number X.K.2 Attachment of Chairman Decision of Capital Market Supervisory Agency Number: Kep-36/PM/2003 concerning Obligation to Submit Periodic Financial Statement; and
- b. Annual report as regulated in Rule Number X.K.6 Attachment of Chairman Decision of Capital Market Supervisory Agency Number: Kep-36/PM/2003 concerning Obligation to Submit Annual Report for Issuers and Public Companies,

are declared do not apply for Issuers and Public Companies that list their securities both in Indonesian Securities Exchanges and foreign Securities Exchanges.

#### **Article 3**

Obligation to submit report referred to in Article 1 shall apply for financial statement ended December 31<sup>st</sup>, 2006 and annual report 2006 period onwards.

### **Article 4**

This Decision shall become effective since the date of its promulgation.

In order that all may be informed, it is ordered that this Decision be proclaimed by publication in the *State Gazette* of the Republic of Indonesia.

#### **RULE NUMBER X.K.7:**

TIME FRAME FOR SUBMISSION OF PERIODIC FINANCIAL STATEMENT AND ANNUAL REPORT FOR ISSUERS AND PUBLIC COMPANIES THAT LIST THEIR SECURITIES BOTH IN INDONESIAN SECURITIES EXCHANGES AND FOREIGN SECURITIES EXCHANGES

- In the event Issuers and Public Companies list their securities with both Indonesian Securities
  Exchanges and foreign Securities Exchanges and provisions of CMFISA regulation stipulating
  deadline for submission of financial statement and that of annual report for Issuers and Public
  Companies and those stipulated by Foreign Capital Market Authority are different, the following
  provisions shall apply:
  - a. deadline for submission of the periodic financial statement and that of the annual report to CMFISA shall follow the regulation of the foreign country;
  - b. Submission of the periodic financial statement and that of the annual report to CMFISA are not later the date of submission of the periodic financial statement to fo reign Capital Market authority;
  - c. The periodic financial statement that is submitted to CMFISA and to foreign Capital Market authority must contain the same information and at least must meet the requirements as stipulated in Rule Number X.K.6 concerning Obligation to Submit Annual Report for Issuers and Public Companies;
- 2. By no means undermining Criminal Provisions in Capital Market, CMFISA may impose sanctions on any violations of this rule, as well as on any Person that causes the violations to occur.
