**TENTANG
PEMBEKUAN SEMENTARA IZIN ORANG PERSEORANGAN SEBAGAI
WAKIL PERANTARA PEDAGANG EFEK
ATAS NAMA RAMOS CANLAS BINSAR
(CONCERNING TEMPORARY SUSPENSION OF INDIVIDUAL LICENSE AS
BROKER-DEALER REPRESENTATIVE OF RAMOS CANLAS BINSAR)**

Dengan ini diumumkan bahwa Otoritas Jasa Keuangan telah membekukan sementara izin orang perseorangan sebagai Wakil Perantara Pedagang Efek a.n. Ramos Canlas Binsar melalui surat Nomor S-800/PM.112/2016 tanggal 27 Oktober 2016 perihal Sanksi Administratif Berupa Pembekuan Sementara Izin Wakil Perantara Pedagang Efek.

Sdr. Ramos Canlas Binsar terbukti melanggar ketentuan angka 6 huruf b Peraturan Nomor V.E.1, Lampiran Keputusan Ketua Bapepam Nomor: Kep-29/PM/1996 tanggal 17 Januari 1996 tentang Perilaku Perusahaan Efek yang Melakukan Kegiatan Sebagai Perantara Pedagang Efek, yang mengatur bahwa Wakil Perantara Pedagang Efek dilarang melakukan transaksi atas nama nasabah tanpa atau tidak sesuai dengan perintah nasabahnya.

Dengan dibekukannya izin Wakil Perantara Pedagang Efek tersebut di atas, maka Sdr. Ramos Canlas Binsar dilarang melakukan kegiatan sebagai Wakil Perantara Pedagang Efek selama 1 (satu) tahun terhitung sejak surat Nomor S-800/PM.112/2016 ditetapkan.

Pengumuman ini hendaknya disebarluaskan.

It is announced that Indonesia Financial Services Authority has temporarily suspended individual license as Broker-Dealer Representative in the name of Ramos Canlas Binsar based on letter Number S-800/PM.112/2016 dated October 27, 2016 concerning Administrative Sanction In the form of Temporary Suspension of Individual License as Broker-Dealer Representative.

Ramos Canlas Binsar violated provision number 6 letter b Rule Number V.E.1, Attachment of Decision of Chairman of Capital Market Supervisory Agency Number Kep-29/PM/1996 dated January 17, 1996 concerning Code of Conduct for Securities Companies Acting as Broker-Dealers, which states that Broker-Dealer Representative may not engage in a transaction on behalf of a client without appropriate authorization from the client.

Following the suspension of the Broker-Dealer Representative License, Ramos Canlas Binsar is prohibited from conducting business activity as Broker-Dealer Representative for a period of one year since the letter Number S-800/PM.112/2016 was enacted.
