ISSUANCE OF OJK BOARD OF COMMISSIONERS DECISION

On Tuesday, March 4th, 2014, the Financial Services Authority (OJK) issued OJK Board of Commissioners Decision No. Kep-08/D.04/2013 on stipulation of PT Bali Towerindo Sentra Tbk.'s shares as Sharia securities.

With the issuance of the decision, the company's stocks are eligible to be included in Sharia Securities List pursuant to OJK Board of Commissioners Decision No. KEP-60/D.04/2013 dated November 19th, 2013 on Sharia Securities List.

The issuance of the decision is a follow up measure after OJK examined the fulfillment of criteria for Sharia securities based on registration statement submitted earlier by PT Bali Towerindo Sentra Tbk.

The data used as examination materials is originated from documents of registration statement and other supporting data, both of written information obtained from the issuer and from other dependable parties.

OJK will periodically conduct a review on Sharia Securities List based on mid-year financial report and annual financial report from issuers or public listed companies. Review on Sharia Securities List will also be conducted if there is an issuer or public listed company whose registration statement becomes effective and fulfills the criteria for Sharia securities, or if there is a corporate action, information or fact from the issuer or public listed company that may cause the issuer or public listed company to fulfill or not fulfill the criteria for Sharia securities.
