- 1. Bapepam may, after notifying the Issuer and the Managing Underwriter, suspend a Public Offering if it concludes that:
 - a. the Registration Statement, prospectus or any other documents submitted as part of the Registration Process, contains a statement that:
 - 1) is false or misleading or omits material facts required at the time and under the circumstances when it was prepared;
 - 2) has become false or misleading or omits material facts due to changing circumstances, and additional information has not been provided to the public, to correct the situation;
 - b. the Issuer or any other Person affiliated with the Issuer in the Public Offering has violated the Capital Market Law or rules thereunder; or
 - c. any Person referred to in letter b has failed to submit any amendments and or information requested by Bapepam.
- 2. The decision to suspend the Public Offering by the Chairman of Bapepam shall be issued in accordance with Form Number IX.A.4-1, attachment 1 of this rule.
- Bapepam may lift the suspension referred to in number 1 in accordance with Form Number IX
 A.4-2 attachment 2 of this rule upon resolution of any matter resulting in the suspension of the
 Public Offering.
