- 1. To become an individual Investment Advisor the applicant shall:
  - a. submit an application to obtain a business license as an Investment Advisor to Bapepam, using Form Number V.C.1-1, attachment 1 of this rule;
  - b. attach a copy of the Investment Manager Representative's license;
  - c. attach a detailed explanation of business activities including any operational means owned; and
  - d. be an Indonesian citizen.
- 2. To become an Investment Advisor in corporate form the applicant shall:
  - a. submit an application to obtain a business license as an Investment Advisor to Bapepam, using Form number V.C.1-1, attachment 1 of this rule;
  - b. attach the articles of association which show that the business activity of the company is to be an Investment Advisor;
  - c. be a company domiciled in Indonesia;
  - d. attach a copy of the license of an individual who is an Investment Manager Representative;
  - e. attach a description of proposed business activities;
  - f. possess operational facilities to support all activities as an Investment Advisor;
  - g. attach an organizational structure; and
  - h. attach a copy of a passport and work permit from the Ministry of Labor of Indonesia, for non-Indonesian personnel.
- 3. To become a Credit Rating Agency an applicant shall:
  - a. submit an application for obtaining a business license as Credit Rating Agency to Bapepam, using Form Number V.C.1-1, attachment 1 of this rule;
  - b. attach the articles of association which show that the business activity of the company

is to be a Credit Rating Agency;

- c. possess the operational means to support all activities in the credit rating process;
- d. attach a receipt of paid in capital and a financial statement audited by an Accountant registered with Bapepam, no more than 60 (sixty) days after the year end statement date;
- e. have at least 1 (one) director and 1 (one) employee one level below the director who have Investment Manager Representative licenses;
- f. attach a copy of a passport and a work permit from the Ministry of Labor of Indonesia for non-Indonesian personnel; and
- h. attach the organizational structure;
- 4. When applications referred to item 1, 2 and 3 of this rule do not meet the requirements, Bapepam shall notify the applicant stating that:
  - a. the application is incomplete, using Form Number V.C.1-2, attachment 2 of this rule; or
  - b. the application is rejected, using Form Number V.C.1-3, attachment 3 of this rule.
- 5. When an application referred to item 1, 2 and 3 of this rule has met the requirements, Bapepam shall issue a license as an Investment Advisor using Form Number V.C.1-4, attachment 4 of this rule.
